# **Chiefs Report: (Deputy Chief Kovalcik)**

All Trustees received a copy of the alarm report.

All Trustees received a copy of the inspection report along with the list of completed inspections for this month.

I am happy to report that Brad Virgils returned to work on November 1<sup>st</sup>. I give him a lot of credit, his Dr. told him he would need 6 more months to heal. He challenged the Doctor and passed the FCE (Functional Capacity Exam) and was able to return to work. On another note I am sad to say that Cmdr. Stec handed in his papers to retire due to some health issues, this was effective November 1<sup>st</sup>.

Our new Firefighter Jim Cotiguala started working on days on November 1<sup>st</sup>. We are putting him through training to evaluate his skills. So far things are going very well and we hope to put him on shift November 14<sup>th</sup>. We have another candidate going through the hiring process. He was scheduled for his polygraph and psyche earlier today. If he passes that we will proceed to the background check. If all goes well he will start on January 1<sup>st</sup>. He is already a Firefighter and a Paramedic. We would do the same thing with him, have him work days for two weeks and put him through training to evaluate his skills and then put him on shift.

Today we are promoting Stan Koy to Lieutenant to take the place of Cmdr. Carpino. Lt. Blondell has been designated as Shift Commander. January we will be promoting Claude Erlewein to the rank of Lieutenant to take the place of Cmdr. Stec.

The Phone system is scheduled to be installed and on line November 30<sup>th</sup>. Once the Engineer went over our current system he found that some things were not compatible. We need to purchase new exterior phones for the front and back and a battery backup system. These items are on the agenda. Trustee Strempek can explain.

On the agenda is a payout to Cmdr. Stec. This is the built up sick time and vacation and holidays he had built up for next year. I went over it with Trustees Chmura and Martell to approve the figures.

The audit is still in progress, we should get a draft in the next couple of weeks. This should be in plenty of time to use for the Levy. We will approve the report at the December meeting.

The workers compensation renewal is due at this time. We spoke with them last Thursday and we should receive our quote this week. They said the pool had a bad year so all rates are going up.

The Firehouse annual Christmas party is scheduled for December 3<sup>rd</sup> from 3pm to 6pm. Please save the date I hope all can make it. We will send an invite in the mail later this week.

Last month I talked about selling the 1996 Pierce Saber. Once we pass the motion I will send the contract to Command Fire Apparatus and they will pay us 5% up front and the remainder of the \$58,000 will be due when they pick up the Engine. This will be done as soon as we put the new apparatus in service. This should be sometime in April 2012.

ISO (Insurance Service Organization) evaluation presentation explaining the process and how our rating has improved from a 5 to a 3. By being an ISO 3 we are now in the top 8% in Illinois. A decrease in our ISO rating also causes insurance premiums to decrease. Deputy Chief Kovalcik thanked everyone involved, Dispatch, Water Department and the Trustees. Trustees stated they appreciate all the hard work and that it is great news.
