# **Chiefs Report:**

All Trustees received a copy of the alarm report.

All Trustees received a copy of the inspection report along with the list of completed inspections for this month.

The new bay heaters have been installed and are working great. Al Air gave a thousand dollars credit on a trade in of the 6 old units.

The new engine is scheduled to be completed on April 23<sup>rd</sup>. The committee is scheduled to do a final inspection on April 24<sup>th</sup> in Appleton. The engine will be delivered to us on or about April 30<sup>th</sup>.

The passing of the International building codes is on the agenda. We have worked with Norridge and Harwood Heights to get everybody on the same code. We approved B&F to put together the ordinance with our amendments. The cost was \$1,750.00 that was approved a couple years ago. The big change will be that any new residential construction must have a sprinkler system. Discussion.

I gave everybody information on the topics of closed minutes that have not been released. If you have any questions let me know and we can ask our attorney at the May meeting. I would like to have him explain the proper procedure on releasing closed minutes.

On the agenda we have the summer interns. Last year we had a total of 600 hours, 300 a piece at \$10 per hour for a maximum of \$6,000.00. Both girls from last year said they wanted to come back if it was available. I left it blank on the agenda in case there were changes.

Deputy Chief Kovalcik and I will be attending the annual conference in Indianapolis from April 19<sup>th</sup> through the 21<sup>st</sup>. The Shift Commanders will be in charge. Claude Erlewein and Dan Davila will be attending with us. There will be no charge for their lodging or for them to attend the conference.

I attended the graduation for our new Firefighter Stephen Swank and our Commissioner Andy Golebiowski, both did very well, they passed their state exam and received their certification. They had very good things to say about the Romeoville academy. Firefighter Swank is now on shift and we have full crew on every shift.

I reported that a technician was working on our cascade system, when he was putting his tools away he tripped over the threshold on the rear entrance door and ended up breaking his hip. He ended up having surgery to repair the hip and I reported everything to our insurance company. They have not filed anything against our insurance as of today.

I will be working with the equipment committee on a new car; I hope to have it on the agenda for May. The state purchase price for the Impala is around \$19,000 and around \$2,000 for all the emergency lighting and transferring the radio equipment. The car should take 60 to 90 days when it is ordered so it will be in the new budget. Chief will get the new squad and the inspector vehicle will be traded in.
