Chiefs Report:

All Trustees received a copy of the alarm report.

All Trustees received a copy of the inspection report along with the list of completed inspections for this month.

The retirement get together for Deputy Chief Kovalcik went very well last Friday. There had to be close to 100 people that stopped by to say their farewell to John. There were many from other departments in our Division, Mayors in our towns, Village Hall employees, dispatchers, public works, police from both towns, many friends and most of John's family. We wish him well, he had a great career.

The new ambulance has been delayed a couple of weeks, we should have the finished product in early June.

Now that Dan has been promoted, he will be taking over John's old car, squad #109. The Fire Prevention Vehicle will be used for the ancillary work which will be doing inspections in the District, 20 hours per week. This will begin on July 1st if the contract is completed.

Lauterbach asked if we would switch our payroll service over to them. This would help with all internal reporting. This would be less work for us and better for them. More control with everything in one place to do W2's, tax payments and pension reports. We would want to make sure Paylocity does the 2nd quarter taxes. We would have to let Paylocity know 2 payrolls ahead of time and then we would have 30 days access to the system before we would be locked out. If needed for a fee we could have access to the system for the remainder of the year. Their cost would be \$28 less per year than Paylocity.

I reached out to our auditors Knutte and Associates on securing a quote for the upcoming audit. They will give us a price for a 1 year and 3 year. I will forward the quote when I receive it.
