## **Chiefs Report:**

We will be doing a record destruction within the next two months; we will be shredding about 25 boxes. We will be getting rid of several boxes of invoices, training reports, maintenance sheets, attendance, banking, call backs, address cards, flu shot paperwork and vehicle check sheets. This will all be approved by the Illinois Secretary of State local records unit.

The monument encasement for the 911 steel has not been replaced yet. They were supposed to be here today but were a no show. Deputy Chief Johnson has had many talks with them and we are holding the last check. Hopefully it will be completed this week.

The roof is completed except for the parapet. We are waiting on the sheet metal workers who are backed up to do their work before it is capped. The only problem they found on the roof was above the radio room. They had to do some repairing but nothing substantial. The company was outstanding to work with.

We are still waiting on some prices from Radco and Call One on installing a T1 line over at St. Rosalie's; we already have a price from Chi Com. Once we get that installed we will see a reduction on the monthly cost of around \$500.

NIAFPD will be holding their annual Trustee training Thursday January 26<sup>th</sup> through the 28<sup>th</sup>. Will keep you posted and register you when the application comes out.

This month's disbursements are very high mostly due to the \$130,906 payment for the roof along with Target Solutions for \$4,856, Bevel Granite for \$5,136 and GCat for \$8,530.

The Christmas party will be held on December 3<sup>rd</sup>, between 3 and 6. Hope all can make it.
