Trustee Romano stated that the balances look good; we have some in reserve for upcoming expenses. Ambulance billing was low this month; the Chief stated this was due to timing. All CD's are locked in at good rates; we have one CD that will be due in September.

Trustee Martell stated that in August when we receive tax money it will reflect the reassessment which was a 17% increase for Norwood Park and around 12% increase for Leyden.

Chiefs' Report:

Chief Vavra included report in Trustee's packet.

Chief will close on house on the 25th of this month; he will be living for 6-8 weeks at his daughter's house.

Deputy Chief Johnson and he went to FDIC and spent 11 hours on the floor meeting with vendors. Received a tremendous education on things and got some good deals on items. Was able to purchase a training program at a 50% discount. Spoke with Firehouse regarding scheduling and will be working with them.

Trustee Martell asked if it is normal to have employees call in at 6:30AM the day of shift. Chief stated that it is a normal practice. Discussion.

Right now we are at 1,054 calls for the year which is the same volume as last year. We did make some operational changes; prior practice was for Commanders to respond to Automatic Aid in other towns. We are not doing that and Commanders will remain in the District unless they call for an officer on the scene. Discussion.

We had an Officer's meeting and it went great. It was the Commanders, Lieutenants, Deputy Chief and Chief in attendance. Discussion. Chief is empowering the Officers.

Interviews have been completed with everyone. The mission and vision words are in your packet. Explained the process of how this came about. Chief would like to bring this back in June to see Trustees feelings.

Chief asked if this Agenda format was better- the Trustees stated it was.

President's Report: Trustee Martell stated he wanted to congratulate Trustee Skyba and Trustee Elect Avino. The board has done a lot and he hates to see Trustee Strempek leave. Trustee Martell wanted to thank all trustees for everything. Things are moving along and we have done some really great things.

Next month is a bifurcated meeting. Discussion.

Committee Reports:

Finance Committee- Trustee Romano stated there is nothing to report at this time. Chief stated we will need to have a budget meeting before the June meeting.

Building and Equipment Committee- Trustee Lymperopulos stated there is nothing to report. Discussion on the radio room copper roof. Will need to tuck-point in about a year.

Information Technology Committee-Trustee Strempek stated he is meeting the Chief on Friday. The internet is slow; Comcast was able to increase the speed at no additional cost. We need to get a switch and currently has 2 quotes so he is working on another quote. Working on getting a new email program. Discussion.

Policy Committee- Trustee Skyba stated they will present under old business the Ordinance for mandatory retirement age for firefighters.

Strategic Planning Committee- Trustee Martell stated we will meet in July. We will update the SWOT analysis and move forward.

Human Capital Committee-Trustee Skyba stated there is nothing to report.

Community Relations Committee-Trustee Jarosz stated he is working on the permanent plaque for the donors.

Pension Fund Committee- Trustee Romano stated that at the last Pension Meeting there was an election for the retiree position. There was a vote and Ray McGovern won the election. Investments are doing better. Trustee Martell stated that they are spending more than they are receiving and have to sell of investments to cover this.

Attorney Report:

Attorney Flaherty stated he has 2 items to update in Closed Session.

There are some Bills advancing- one is state standard for Fire Chief. Another bill that was stalled for full time workers who work part time at another department they would have to pay pension contribution to the full time department.

New Trustee will need to take Open Meeting Act; Trustee Elect Avino stated he is already certified. Discussion. He will also be taking training in Peoria that will allow for pay increase.

The head of Illinois Fire Chief's, Tim Sashko, resigned recently. They are looking for new leadership.

This Ordinance rescinds Ordinance #00-2. Attorney Flaherty stated this is a clarification on when the Ordinance takes effect at age 63- which is the first day. It also made the Fire Chief/Administrator exempt from this. Discussion.

Trustee Lymperopulos asked how many firemen will this effect by having it age 63. Discussion. Chief states this is to help minimize the risk of injury or illness.

Attorney Flaherty states we are entitled by state law to specify a retirement age. Discussion.

Chief stated that Norwood Park have never used this service before but the Village of Norridge does and Chief has worked with them when in Buffalo Grove. They perform grant research, filing and follow up. This is the base product but can expand to policy and procedure and/or accreditation. The first grant is for 3 Service Pro computers and we could get 3 computers a year for 3 years. Discussion. Also looking into grants for ballistic vests and helmets. Discussion.

Trustee Martell states that we have had a contract with Village of Norridge for approximately \$94,500 a year for Dispatch services. This contract ends November 30, 2017. MCD takes effect August 1st, since Norridge is honoring our contract. There is a RFP for Dispatch services since this is for \$20,000 and we have had success with our Paramedic contract and Ambulance Billing. Attorney Flaherty stated this is a little different than other RFPs. This is not a strict sealed bid where you have to take the lowest responsible offer. Dispatch is exempt from this so there is some latitude.

Trustee Martell stated they need to be competitive. Chief states there are only a few in the area that can meet the coverage area that they will send it to. Discussion.

Chief explained the purpose of why the consolidation law took place. Discussion.

Trustee Martell asked if the RFP is going to be sent to the County. Chief stated that they are just getting into this and have never dispatched fire. Discussion. He will send to County.

Trustee Martell asked Attorney Flaherty what happens if a town pulled out of the dispatch group where they fall below 25,000. Attorney Flaherty stated they would merge with another. Discussion.
