Chiefs' Report:

Chief stated that all Trustees have received a written report.

Corkill insurance was in and we discussed the renewal. Discussed the option to increase the Umbrella Policy to \$10 million. Discussion.

NIAPFD Annual Conference is January 23-25. Attorney Flaherty stated the 23rd is for Pension Fund.

Call volume is up by about 200 from last year at this point, which is about a 5% increase.

Truck 104 is coming back from the repair shop tomorrow. The mechanic states that parts are becoming obsolete. We will need to have a serious talk on possibly funding a Truck.

Woman's quarters are being created with the bathroom remodel money. It is almost complete.

Scissor lift is on the agenda. We will be using part of the \$16,000+ Safety Grant money we received from IPRF.

The LUCAS 3 device will use the remaining IPRF Safety Grant money if approved tonight. Commander Peistrup did research on the device and received quotes. Discussion on device and a 30% chance for (ROSC) Return of Spontaneous Circulation.

Trustee Rybak asked if there was a pediatric device. There is not. Also, this cannot be used on extremely obese patients.

Trustee Rybak asked if the call increase and cancel en route was the automatic aid calls. Discussion.

Finance Committee- Trustee Romano stated there was no committee meeting. The Levy was completed by Chief Blondell and Cyndi, then reviewed by Attorney Flaherty.

Building and Equipment Committee- Trustee Rybak stated that the Chief gave a rundown of the items on the agenda. Firefighter Mark Blondell will come give an update on the bathroom remodels if needed.

Policy & Strategic Planning Committee- Trustee Kolaski stated there is nothing to report, will have a meeting next month.

Community Relations Committee-Trustee Avino stated there is nothing to report, will have a meeting soon.

Attorney Report:

Attorney Flaherty gave an update on the Pension Bill that passed the House yesterday and Senate today. It is expected to become law January 1st. The Pension Fund will no longer be responsible for the investments/assets, there will be a Fire Fighter Pension Fund that will handle all the money (except Chicago). The NPFD Pension Fund will be responsible for everything but the finances (new hires, disabilities, etc.)

Training will include a 16 hours class and then 8-hour annual renewal. 4 hours class on the new policy. This is for both fire and police. Tier 2 will receive new benefits, COLA will be CPI or 3%, whichever is less. The State will not be allowed to sweep. More information will be coming.

Marijuana will become legal as of January 1st. Police and Fire Departments can adopt a policy that you cannot use on or off duty if the drug policy is not bargained. NPFD drug policy is bargained. Will need to have a policy meeting to decide. Marijuana needs to be moved from the column of prohibited to where alcohol is. If you have a CDL then you cannot use because of Federal Law. Discussion.

Attorney Flaherty stated that disabled firefighter Nagrocki was sent for his medical evaluation on October 30th and we are waiting for the report.

Attorney Flaherty thanked Trustee Romano for his service.
