We have increased the budgeted amount to \$85,000 and may need to change the amount that was previously approved. We should know more at the next meeting.

The asphalt bid is not ready yet. Chief has spoken to Ron from Harwood Heights and was introduced to the engineer that they use. He is going to assist with the bid.
